I know we have members who are not only personally affected, but who are also working in the area with sophisticated technology helping to make the area safe and accessible again. My hope is that even amongst their damaged homes and lives, they can enjoy some festivities over Christmas and New Year. NZIS is a resource ready and willing to assist in the affected area. For this to occur we need to open the communication lines and to focus our involvement as is appropriate to support the immediate, short and long term needs of these affected communities. In response, we are developing an NZIS National Emergency Management Plan and have created a section on the website for sharing information. A special interest group has also been progressed. Last month we welcomed new LINZ chief executive, Andrew Crisp. He has a broad range of experience, including in policy regulations, operations, strategy and corporate functions and has held senior roles at the Treasury, Department of Labour, and Ministry for the Environment. I am looking forward to meeting with Andrew in the new year and to developing our relationship with his executive team.

LINZ is continuing to make good progress on the Advanced Survey and Title Services (ASaTS) project. They are progressing through the procurement process and working with one supplier through the diligence phase before a decision is made to award a contract in mid-2017. I had the pleasure of attending another very successful NZ Spatial Excellence awards evening in November where for the third year in a row, the best of the industry received recognition and applause. The Premier Award was won by Wellington City Council's submission, Living Lab. I congratulate all this year's finalists and winners. As a founding partner of the awards it is very gratifying to see our support for the spatial profession contributing to the success of the awards. These awards are gaining recognition and are going from strength to strength each year.

I would like to thank all the people who took time to join our first ever Stakeholder Workshop. Nearly sixty people including representatives from branches, streams, National Office, Young Professionals, Council and Board met at the National Library in Wellington prior to the AGM in late October. The session was a great success with the following topics covered; certification, conference and awards, membership model and policy, NZIS future - 'blue sky' thinking and key membership needs. Although the sessions were conducted at a rapid pace due to time restrictions, we managed to get some excellent ideas and feedback on issues. The feedback so far been very positive with participants finding it extremely valuable. The feedback received can be located on the Governance webpage. The feedback on the effort put into the NZIS Certification review is overwhelmingly positive from members but there is still a lot of work to be done before we can roll out a system that will meet all the expectations of both our profession and the public. The recent stakeholder workshop was especially helpful and there will be a focus on rounding out the process over the next six months as we head towards a roll out around next year's AGM. My thanks to Andrew Stirling especially for his endless hours on this project.

On the advocacy front, the Cadastral Survey Act Working Group has been working hard in recent months to ensure LINZ is aware of our frustrations and to provide some thought-leadership on any changes that may be progressed. Much has already been progressed but there will be more to report in this area in the coming year.

Events under the CPD programme offered to members have received good registration numbers in the latter part of this year - in particular, the Vertical Data Improvement seminar and the Processing UAV Data webinar.

We have recently re-launched the webinar programme using Adobe Connect which has been well received.

We are anticipating a full review of the CPD programme in 2017 to ensure the system in place is robust and can continue to meet members needs in the future.

National Office has not been without its challenges during the year with illness and departures meaning we have rarely had a full contingent on deck. Lauren McGee recently left for new opportunities and we welcomed Tara Govind as the new administration and event manager back in May. We will be advertising the Relationship Manager role shortly and hope to make an appointment in the early New Year.

Finally, I am delighted to welcome our two new Fellows; Andrew Stirling and Simon Inroside, who are both deserving of this honour.

I wish everyone a restful holiday season and a safe return to work in 2017.

## Recent Legislative Case-Note Summaries

From Thomson Reuter’s “Your Environment” and “Alert24 –Land”.

Summaries of cases from Thomson Reuter’s "Your Environment".

This month we report on nine court decisions covering diverse situations associated with subdivision, development and land use activities from around the country: A possibly inconclusive case relating to zoning and prohibited activities and possible trade competition at and nearby the Paraparaumu airport; we have included more cases than usual for reading on wet days at the bach/crib.

- A successful appeal by Z Energy against refusal of Western Bay of Plenty District Council for consent to a service station at the junction of SH 2 and SH33;
- A successful appeal by owners of an existing non-residential building at Grey Lynn, Auckland against refusal of Auckland Council of consent to establish a café. The situation was made more complex by the introduction of the proposed Auckland unitary plan;
- A decision on enforcement orders relating to earthworks undertaken and construction of a dam on proposed subdivision land near Palmerston North;
- The final decision of a series of cases about continuation of quarrying activity on Saddle Hill near Dunedin;
- A case relating to proposed stopping of an unformed road and establishing part of it as esplanade reserve;
- A case interpreting terms of a mediated settlement of an appeal relating to a resource consent for establishment of a campground on coastal land near Whangarei;
- A further high court appeal relating to several enforcement cases taken by Auckland Council against a man who had undertaken developments without resource consents or building consents on several properties across the Auckland region.
- A decision of the High Court about discovery of documents relating to judicial review of a non-notified consent granted by Auckland Council.
