## IMPORTANT COMMUNICATIONS MESSAGE FOR MEMBERS




Email is the official channel NZIS uses to communicate with members on all important issues including sending out membership alerts, updates, advocacy items and invoices.

## LINZ NEWS

### **NZVD2016 Heights in Geodetic Database and the LINZ Data Service**

Following the notification on 26 January 2018, NZVD2016 heights have now been updated and are now consistent with the NZGD2000 ellipsoidal heights within Landonline, the Geodetic Database, the LINZ Data Service.

The heights were successfully updated on 1 February and now have the description “National Geodetic Adjustment NZGD2000 20171201 update” with a calculation date 14-Jan-2018 to match the NZGD2000 from which they are based.

If you were using NZVD2016 heights from the Geodetic Database between 15 January and 2 February 2018 or the LINZ Data Service between 23 January and 5 February 2018 please be aware many heights will have changed.

## ADVOCACY UPDATE

### NZIS Governance Review

NZIS Council has formally appointed Governance Review Panel members: Dr Bruce Anderson (Chair), Andrew Stirling, Mark Allan and Mike Benning (Members' Representative). They have started work on the review and will update Council on their progress in April. The review will be considered at the 2018 AGM. The Terms of Reference for the Review may be found [here](#).

### Application to the Environment Court for a declaratory judgment relating to conversion of cross-lease title

NZIS has joined Don McKay in an application to the Environment Court to determine whether the conversion of a cross lease title to a fee simple title constitutes a subdivision in terms of section 218 of the Resource Management Act 1991. His Honour Judge Kirkpatrick is the presiding Judge for the case and has appointed an *amicus curiae*, Dr Palmer, to assist the Court by considering the legal issues and making independent submissions on them. ## Te Ture Whenua Maori Act (TTWM)

At the time the Bill was withdrawn from the legislative programme in December 2017, a media release said that TTWM reforms would be relaunched in 2018 (as advised in the [February 2018](#) issue of Newslink). The latest information obtained from Te Puni Kokori is that there will be no such relaunch, but this has not yet been widely publicised.

## Surveyor-General's Review of rules for Cadastral Survey

This review has now entered Stage Two (January to June 2018) which will be the response to the issues identified in Stage One and will include stakeholder consultation on the Surveyor-General's proposed changes. The Cadastral Stream prepared a [submission](#) on Stage One and LINZ has taken up NZIS's suggestion and formed a reference group. We understand that LINZ has selected the members of this group and will be making an announcement shortly. The members of the group will provide technical input on the review. The Cadastral stream will be looking for members to help provide feedback when requested by LINZ as part of next stage of the Rules Review process. We encourage all members with an interest in Cadastral Surveying to keep an eye out for and provide feedback when requested.
