Environment Court Decision on Cross Lease Titles Released

The long-awaited decision has been received on Don McKay's application that was supported by S+SNZ. The application was for a declaration from the Environment Court, that the conversion of cross-leased titles to fee simple titles is not a subdivision within the meaning of section 218 of the Resource Management Act 1991. LINZ Update on the Land Transfer Act 2017

As previously advised, the Land Transfer Act 2017 is expected to come into force on 12 November 2018.

In September, we submitted the final draft regulations that support the Land Transfer Act 2017 (LTA) to Cabinet for consideration. Subject to approval from the Governor-General, these regulations will come into effect from 12 November 2018.

The Registrar-General of Land has revised the draft standards and the directive to take into account the feedback LINZ received during the [final consultation stages](#). These will be published on our website on Thursday 11 October 2018.

We are also developing a set of factsheets showing the key changes customers will need to know about. You can find the factsheet for surveyors on the LINZ website <https://www.linz.govt.nz/land/surveying/csd-preparation>. We are currently developing a fact sheet for lawyers and legal executives, and one for local councils. Both of these factsheets and any transitional guidance, will be available on our website and provided to the relevant member organisations towards the end of October.

The Landonline application will also be updated to reflect these changes. Further guidance on this will be available towards the end of October.

What's changing?

The new Act will ensure New Zealand can continue to rely on a modern, world-leading land transfer system. The Act will bring the key changes below:

- terminology changes
- a new definition of 'fraud' which effectively aligns it to current case law
- changes to the compensation rules regarding assessment/valuation of loss
- an exception which allows the court to restore a title to the former owner in cases of manifest injustice
- correction powers around compensation in cases where landowners haven't taken reasonable care in managing their property
- land covenants in gross can be permitted
- non-disclosure provisions to suppress landowners details on the grounds of safety.

CASE NOTES

Summaries of cases from Thomson Reuter's "Your Environment".

This month we report on eight court decisions covering diverse situations associated with subdivision, development and land use activities from around the country;

- A successful appeal against refusal of consent by Auckland Council to an application for subdivision on the outskirts of Warkworth;
- An unsuccessful appeal by an Auckland property owner against convictions for damaging a historic basalt boundary wall in Epsom, Auckland;
- An interim and a final decision on a road stopping appeal at Hamilton;
- A final decision on an appeal relating to a boatshed and jetty in Queen Charlotte Sound;
- A sentencing decision resulting from a successful prosecution of a subdivider of land at Pyes Pa, Tauranga, whose actions caused environmental damage;
- A costs decision resulting from an appeal against the consent of Auckland Council to a development and subdivision at Papakura;
- A successful appeal by an applicant against refusal of consent by Tasman District Council to a proposed subdivision of rural land to facilitate extension of a quarry that is an important source of rock for roading in the area.
